TRUSTEES REPORT FOR THE YEAR ENDED 31ST MARCH 2012

The Trustees have pleasure in presenting their report and financial statements of the Charity for the year ended 31st March 2012.

The Treasurer throughout the period was Mr D Borland OBE.

Charitable objects

The charity was established in 1986 with the original object being to provide financial and other support for persons who are training to become or are already in full time pastoral and evangelical work of a Christian nature; to promote the Christian faith among school children and to work alongside ministers and elders of any Christian church in furthering the Christian faith.

Thereafter the Bethany project was established with its aims of helping the most under privileged, deprived and vulnerable members of society, especially orphaned children.

In November 2011 the Charity changed its name to emphasise that its prime purpose was to support the Bethany Orphanage based in Tanzania and its young people.

Structure, Governance and Management

The trust is a registered charity, number 517995 and is constituted by Deed of Trust. The charity can be contacted at 2 Aspen Fold, Oswaldtwistle, Lancashire.

The procedure for the appointment of new Trustees is through consultation between the existing Trustees and the charity's supporters. When new Trustees are inducted their responsibilities are made clear to them by the existing Trustees and they are furnished with relevant booklets, etc. for their information.

Activities

During the year the Charity has donated the recurring fixed assets which were unrelated to the support of the orphanage in Tanzania, to local charitable organisations.

The Trustees have undertaken a comprehensive review of the structure of the Charity. The orphanage in Tanzania is registered as an NGO with separate Trustees and a separate constitution to that of the Charity. Therefore the Trustees have concluded that assets held by the orphanage should be recognised within the NGO as should all expenditure incurred directly by the NGO. The Charity will continue to support the NGO by making grant payments to it and these are now disclosed separately within the accounts.

The Trustees will continue to ensure that all monies granted to the NGO are spent in an appropriate manner and that the management of the NGO and the operations and ethics of the orphanage accord with the objectives of the Charity.

During the year the Charity made grants of £125,159 to the NGO.

A summary of the activities over in Tanzania is given below:

The year was quite an eventful year in all areas.

Firstly work was started on a new Boys dorm in October 2011 and by the end of the financial year the dorm was complete but for the finishing touches. It can accommodate 27 boys and one carer. It has 3 showers, 4 washbasins, 3 WC's and 2 urinals.

During the year it became apparent that the faithful old Land Rover was coming to the end of its useful life. It was costing more and more due to constant repairs. Therefore a fund was set up to raise the £25,000 to purchase a new vehicle. As at the end of the financial year the fund had reached a total of £14,300.

Sadly fulltime education on site was stopped by the local Tanzanian authority in January even though the children were progressing well and the private school they were registered with were very happy with the arrangement. The local authorities argument was that Bethany was not a registered school so therefore we should not educate children. The children were therefore returned to the local village government school reverting to the Swahili syllabus and where resources and teaching standards were poor.

In the past the local authority had allowed some of the older children to come to England to study at Accrington and Rossendale College. This year things had changed and the local Tanzanian social welfare officer denied them the opportunity insisting that they should finish secondary and high school first. Therefore three of our girls who had passed their IELTS English in Nairobi and been accepted at Accrington and Rossendale College were denied this opportunity.

On a happier note we can report that during the first two weeks in July 2011 two of our young women. Jesca and Emma who are presently studying for their BA in Education at Blackburn College held two, 3 day seminars for carers from 4 other local children's homes. A total of 27 carers and managers attended the seminars whilst a repeat of the seminars were held for our own carers and our secondary and std 6 & 7 girls.

We drew up plans in January 2012 to build a primary school but we feel it will take some time before funds become available for such a project.

The orphanage also held a Reunion weekend for all those who had left Bethany to return for a celebration meal and to be reunited with their younger brothers and sisters. It was also an opportunity to find out how they were progressing with an opportunity to address the children about life after leaving Bethany. This for the main part appeared a very positive experience and very encouraging for our older children who were determined to study harder.

On the whole numbers remained about the same with approx 110 children on site with some leaving and some joining.

Plans for Future Periods

The Trustees plan to continue to make grants available to the Bethany Project Tanzania to enable it to develop the Tanzanian property to enhance the education of the children.

Voluntary Help

The financial statements exclude costs for voluntary help which cannot be quantified.

Reserves and Risk Policies

Unrestricted funds are needed to ensure the continuance of the charity's work. The Trustees consider it prudent that unrestricted reserves should be sufficient:

- a) to avoid the necessity of realising fixed assets held for the charity's use;
- b) to cover four months expenditure.

At the year end unrestricted reserves were sufficient to cover this.

The level of reserves is monitored and reviewed by the Trustees on a regular basis.

The Trustees are assessing the major risks to which the charity is exposed and will investigate systems to mitigate exposure to these risks.

Financial Review

The income, expenditure and resulting deficit for the year, and the charity's financial position at the end of the year are shown on pages 5 and 6 of the financial statements.

A trustee, Mr G. Pountain and the treasurer make regular trips to Tanzania during which they undertake an internal review of the accounting for expenses at the orphanage to ensure grant monies are being appropriately expended.

The Trustees are satisfied that at the year end the charity is able to meet its ongoing liabilities.

The charity's balance sheet at the year-end showed a reasonable position.

Finally our thanks to our faithful supporters who continue to fund the children's home. Without you we would not exist and many children may not have survived the harsh life in Tanzania when they find they have no family to support them.

We thank God for the support of all those who are faithful in their giving so that the charity's work can continue.

REPORT OF THE INDEPENDENT EXAMINER TO

1. Accounting policies

a) Accounting convention

b) Donations

c) Tangible fixed assets
